- a. Davis Double Century, Director-at-Large (Stewart Thompson)
 - i. Status Report / Needs:

Davis Double Century (DC) is to be held on Saturday the 20th of May, 2023.

There are currently 163 registered riders and Stewart's expectation targets 250

Statistics - 25% of the riders have never done a DC before;

40% haven't done the Davis DC before:

DC Management has asked participants to bring head and tail lights;

Volunteers - Presently 42, but need 82.

T-shirt orders are placed.

Some permits are pending, but are in sight of getting them.

Permit fees higher due to inflation.

Food (Harvester, Nugget) orders placed.

DBC banner (with Maria) would be used for the DC event.

Membership Renewal is almost completed for 2023. April saw 12 renewals. Members who have not renewed would be archived by Wild Apricot. Introduced increased prices for non-recurring (one-time) payment. Many people have requested transition. No one has complained. Pilot working as planned.

Voler - Jersey prices have significantly increased. A minimum order quantity is required for event jerseys. Foxy's event jerseys helped generate revenue in the past for the club – \$11 per jersey.

Membership benefits – insurance for riding members.

Class 2 electric bikes are allowed on rides and covered by insurance.

\$500 of additional income was recently received from last year's Foxy's in the form of a refund from Napa County.
