2. Consent, informational items:

- **a.** The minutes of the June 5, 2023 of the Davis Bike Club (DBC) Board of Directors (BoD) meeting were unanimously approved with no comments or changes. (Motion Waters; Second Bhat)
- **b.** Pursuant to comments received from Stewart Thompson regarding the DC noted in the above approved Meeting Minutes, certain sections as discussed are in question and have been deleted pending further discussion by the BoD. Please refer to **Tabled Items** (for Future Discussion) in these Minutes for the details of the deletions.



3. Unfinished Business:

- a. Open 2023 Officers, Directors, Appointees
 - i. The following positions remain to be filled and were discussed:

President - Dave Joshel volunteered to serve as interim President for the remainder of this fiscal year. Robert Enzerink offered a Motion to accept, with Stewart seconding the motion. The motion was unanimously approved.

Vice President and Race Team positions were discussed with Robert Enzerink inquiring whether correspondence to these two Open positions is sitting idly without action in unused accounts or have they been forwarded to someone? The suggestion was made to check with Hector, which Robert will do.

Social Media Manager – No discussion

Treasurer – Rick Waters has possibly found someone willing to take over as Treasurer, but individual is traveling and then wants to know more about the job. Rick will keep BoD informed.

b. Board Restructure to reduce / restructure officers –

4. Directors' reports (as requested):

- a. Foxy's Fall Century Director (Dave Watkins)
 - **i.** Early registration is ahead year to year (\$ 13,000). Early Bird registrations are complete.
 - ii. Currently need volunteers to Captain the water stop at Circle Oaks and for Route Marking.

- iii. Discussion about spreading publicity of Foxy's to other clubs. Maria volunteered that she has laboriously compiled an email address contact list for local clubs. Discussion continued about Maria's making this list available to Robert for adding into the DBC Google Drive.
- iv. Robert Enzerink advised that he was or would be in contact with Mike Fee and Mike Rob (Pannier) to finalize Foxy's finish line meal.

b. Outreach Director (Maria Contreras-Tebutt) –

- i. Maria brought up Korea Tour of a few years ago, which Brent Burkholder and Sung Moon did, and wondered at the possibility of a re-do?
- ii. Related to this, Rick Waters brought up the idea of putting Tour support back into the Touring program (paying people to go on vacation tour supplement that was removed at some undetermined time in the past.

c. Membership Director (Aimer Bhat) -

- i. Memberships have slowed as most renewals occur in March, but the auto credit card discount appears to be working well.
- ii. The questions was raised about a prior policy of paying for 4 years of membership and getting a fifth membership year free. The ensuing discussion informed that the Wild Apricot software made this difficult to implement and resulted in an open question whether the Club really wanted to investigate to bring this back? Consolidation and reorganization of media accounts:
- **iii.** As to social media, Robert Enzerink advised that he has been consolidating the Facebook and Instagram accounts. The user names and passwords for these are in Google Drive.:
- iv. Amir suggested trying different small / local events with offered gift card or other prizes to get folks to participate and post on social media

d. Treasurer (Rick Waters) -

- i. Rick provided the June and July Financial Reports, which can be found attached and incorporated into these Meeting Minutes.
- ii. John Hess was asked about the status of Annual Financial 'Look-over', which John advised that he would look into with Manny
- iii. A question was asked as to why there was money in the Randoneurring account.

 Deb Banks advised that for the upcoming Paris-Brest-Paris event that drop bag service is provided for US and Canadian riders, for which the entrants have paid.

 These funds will be used to pay for Sprinter Truck rental and expenses; hence, the money goes in and out of the DBC account at no cost to DBC.

e. Philanthropy Director (John Hess)

- i. John advised that there is not much activity right now, but the funds for compensating the IBHoF for meeting access for 2024 are in the budget.
- ii. Other recipients of our philanthropic funds are unidentified and the funds unencumbered.

f. Davis Double Century, Director-at-Large (Stewart Thompson) –

- i. Stewart advised that the accounting for the DC Is complete and that we made \$ 11,000, which announcement earned a rousing round of applause.

and Robert Enzerink. This survey will be provided to the BoD before going live to the

membership.

c. A short discussion was held regarding the topic of revitalizing the Club. Deb Banks

suggested a meeting with Bike Hiker and / or Wheelman to talk about problems, to

brainstorm ideas of ride collaboration.
