2. Consent, informational items:

a. The Minutes of the April 1, 2024 Davis Bike Club (DBC) Board of Directors (BoD) meeting and Final March, 2024 Fiscal and Financial Reports were unanimously approved to be posted to the DBC Website and to the historical record on the Google Drive.

3. Unfinished Business:

- a. Open 2024 Officers, Directors, Appointees
 - i. The Tour & Ride Director position remains to be filled:



- **b.** Conversion of the DBC from a 501(c)4 to 501(c)3
 - i. The President proposed that a committee be established to pursue the Pros and Cons of conversion from a 501(c)4 to a 501(c)3. The Secretary and Outreach Director volunteered to serve on such Committee and to report their findings back to the Board for the June BoD Meeting.
 - **ii.** The President will contact past Board President Bill Bernheim for possible insights, assistance, and direction for the committee's work.
 - **iii.** \$1,000 was approved for the Committee's study in the event paid counsel is needed.
 - iv. The Treasurer noted that approximately \$1,300 could be saved annually in the Club's Gmail account by adopting the 501(c)3 status.

4. Directors' reports (as requested):

- a. President (Dave Joshel)
 - **i.** The Listserv is an antiquated means of communication for the Club. The President will work with the DBC Webmaster, Bob Starkston, for alternatives.
 - **ii.** The President provided a list of known DBC Lifetime Service Award recipients, which will be sent to the Webmaster for incorporation into the Website. A copy of this preliminary listing is attached to these Minutes.
 - **iii.** It is hoped that the list can be enhanced over time with photographs of the recipients and that the list can be fleshed out for completeness.
 - **iv.** The Club will address in the Fall the addition of new recipients for recognition at the December Holiday Party. Initial suggestions included: Rick Waters; Diane Richter; Bill Bernheim; Eleanor Olson.
- **b**. Davis Double Century, Director-at-Large (Stewart Thompson)
 - i. The DC Workers Ride will be held May 11th.
 - **ii.** The event has 198 registrants so far and is down a bit from expectations, but DC participants are down nationally. Currently forecasting 225 entrants when including late registrations.
 - ii. \$30,000 has been received so far.
 - **iii.** Volunteering looks good, though there remain a few rest-stops that need to be addressed, especially for late food and clean up.
 - iv. The permitting process continues to be the last-minute issue every year.
 - **v.** Insurance coverage requirements may expand to include Workmen's Compensation for the volunteers next year along with the \$2 million liability.
 - vi. Treasurer has the equipment needed to take credit card entry fees.
- c. Vice-President (Michael St. Paul) Absent and no report

f. Treasurer (Kurt Giles)

- i. The April Fiscal and Financial Reports were presented and can be found as attachments to these Minutes.
- **ii.** Given our financial condition further discussion by the Board is warranted towards increasing philanthropic donations.
- **iii.** A thank you note was received from Marilyn Dewey in response to the floral display given by the Club in Bruce's memory.
- **ii.** The March Madness proceeds have been donated to the Bike Campaign through Big Day of Giving and were matched.
- **iii.** Donations were received in memory of Bruce Dewey from Wayne and Joan Anderberg and Bobbie Bolden. A copy of the note from the Anderberg's can be found as an attachment to these Minutes. Responses to these donors will be taken care of by the Secretary as well as notice given to Marilyn Dewey of these generous gifts. The funds will be applied to the August Ice Cream Social.
- **iv.** Another scam application was received attempting to extract funds for registering the Directors of the Club. Be vigilant out there. The scam artists are everywhere.

g. Philanthropy Director (John Hess)

- i. Records of recent (2018 and 2019) DBC philanthropic donations were provided for posting on the Website. A copy of these can be found as an attachment to these Minutes.
- **ii...**Due to the pandemic, donations were curtailed for several years. Fiscal year 2022-23 included the Bike Campaign, SABA and the Bicycle Hall of Fame. The current focus on 'giving' is towards cycling related activities and organizations.
- iii. Expansion of the Philanthropy budget will become an element of consideration in the 501(c)3 / 501(c)4 discussions.
- g. Director-at-Large, Ultra Cycling Events (Deb Banks) Absent and no report.
- h. Race Team Director (Heidi Verbeeck; Ray Spore)
 - i. The Race Team has enjoyed recent success as riders achieved high finishes in the Collegiate Nationals Criterium and Time Trial events.
 - ii. A Mountain Bike Skills ride and clinic will be conducted on May 18th(?) and will

be advertised to the Club.

- **iii.** Permits are in hand for the July 4th Criterium and local businesses are being notified of the event.
- iv. Race Team members have been informed that half of their volunteer responsibility is to support the Criterium. The Race Team will also be volunteering to help with the cleanup of the DC.

i. Secretary (Russ Ewers)

- i. The Membership Survey results that Robert Enzerink recently presented to the Board will be presented to the Club at the June Membership Meeting (6/10/24).
- **ii.** Curious how the results of that Membership Survey compared with the Club By-Laws Objectives, the Secretary sent out a short Performance Survey to the Board. A copy of those Survey results can be found as attachments to these Minutes.
- **iii.** The 'grades' by the respondents were 'average', but there is more analysis of those results that needs be done.
- **iv.** A controlled expansion of this short survey to a select group of the membership may be of value and included in the June Membership Meeting Program.
- **v.** The 'grades' of several of the Objectives may be enhanced by consideration and adoption of the 501(c)3 organizational status.
- vi. A conflict exists on the Website between the Mission Statement and the By-Laws Objectives. These differences are outlined on the attached spreadsheet.vii. It was agreed that the 2019 By-Laws Objectives should govern. The Secretary

will coordinate with the Webmaster for the necessary conformance corrections.

j. Outreach Director (Maria Contreras-Tebbutt)

i. Commemorative bike path dedications can be proposed to the City of Davis and will be supported by Jennifer D'Onofrio. No particular dedications are in mind at this time.

k. Foxy's Fall Century Director (Eric Senter)

- i. Begun coordination with CHP. Permitting tasks will begin in June by Rich Rifkin and Rob Sousa.
- ii. Eventbrite registration site is nearly completed. Fees for the short rides will remain the same. The longer distance ride fees will be bumped up slightly and triggered by the timing of their registration: \$75 for early; \$85 for regular; and \$100 for late

- **iii.** Online ads should begin this month or next. Print ads to begin in July, August, and September.
- **iv.** Posters, post cards and other materials will be done and coordinated with Outreach.
- v. All needed facilities at the Veterans Memorial Center have been made. Eric is coordinating with Stewart to begin the necessary work on Eventbrite and Sign-Up Genius.
- vi. Plans for the final meal are still under consideration ... Race Team? ... Dos Coyotes? ... Other?
- I. Website Manager (Robert Starkston) Absent and no report.
